*This rental application and applicable fee must be submitted to the Borough of McKees Rocks by March 31st, if property will be occupied at any time during the calendar year. A 20% monthly penalty fee PER UNIT will be applied after March 31st in accordance with Ordinance 1753. Failure to apply could result in a fine up to \$600.00 daily in accordance with Ordinance 1753.
