**AN ORDINANCE OF THE BOROUGH OF MCKEES
ROCKS, COUNTY OF ALLEGHENY, COMMONWEALTH
OF PENNSYLVANIA, INCREASING THE LICENSE FEE
FOR VIDEO, ELECTRONIC OR MECHANICAL
AMUSEMENT DEVICES, PINBALL MACHINES, POOL
TABLES, DART BOARDS, BOWLING MACHINES, MUSIC
BOXES AND THE LIKE**

WHEREAS, the Borough of McKees Rocks maintains a Schedule of Fees, which may be amended from time to time; and

WHEREAS, on April 14, 1982, the Council of McKees Rocks Borough enacted Ordinance No. 1409 which provided for the regulation and licensing of mechanical amusement devices and music boxes, which included the establishment of fees associated therewith; and

WHEREAS, the Schedule of Fees has been amended in the past, including by Ordinances 1481, 1527, 1535, 1579, and 1706 respectively; and

WHEREAS, Borough Council wishes to amend the Schedule of Fees to increase the annual licensing fee for video, electronic, or mechanical amusement devices and pinball machines from \$650.00 to \$700.00; and

WHEREAS, Borough Council wishes to amend the Schedule of Fees to increase the annual licensing fee for pool tables, dart boards, bowling machines, music boxes and the like from \$175.00 to \$200.00;

NOW, THEREFORE, IT IS ORDAINED and ENACTED by the Council of the Borough of McKees Rocks, as follows:

SECTION 1: Section 6 of Ordinance 1409, as amended by Ordinances 1481, 1527, 1535, 1579, and 1706 shall be amended to read as follows:

Section 6: Following the waiting period of Section 4 of Ordinance 1409 and 1481, owners of video, electronic or mechanical amusement devices and music boxes will pay a yearly license fee for each machine as follows:

- A. \$700.00 for video, electronic, or mechanical amusement devices and pinball machines.
- B. \$200.00 for pool tables, dart boards, bowling machines, music boxes and the like.

Upon receipt of payment for each machine, the Borough Secretary shall issue a license to each applicant, Such license shall be valid for the entire calendar year for which it is issued and shall expire following the last day of such calendar year. However, should any such device or box be installed after July first of any year and application therefore be made after such date, then in such event the license for the particular year shall be one half (1/2) of the regular license fee.

SECTION 2: Any Ordinance or parts of Ordinances conflicting with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION 3: The Schedule of Fees contained herein may be modified by time to time in the enactment of a later resolution by the Council of McKees Rocks Borough.
