**AN ORDINANCE OF THE BOROUGH OF MCKEES  
ROCKS, COUNTY OF ALLEGHENY, COMMONWEALTH  
OF PENNSYLVANIA, REPEALING AND REPLACING  
ORDINANCE 1515 AND AMENDING ORDINANCE 1406  
REGULATING THE LICENSING FEES OF THE SALE OF  
GOODS OUT OF DOORS**

WHEREAS, the Borough of McKees Rocks maintains a Schedule of Fees, which may be amended from time to time; and

WHEREAS, on February 9, 1982, the Council of McKees Rocks Borough enacted Ordinance No. 1406 which regulated the sale of goods out of doors, set forth licensing requirements and established penalties for violation thereof; and

WHEREAS, Section 5d of the Ordinance states: "No such license shall be issued unless a license fee of Five (\$5.00) Dollars is first paid to the Borough Secretary; and

WHEREAS, on December 16, 1991, the Council of McKees Rocks Borough enacted Ordinance No. 1515 which increased the daily licensing fee to \$10.00 per day and established a seasonal licensing fee of \$200.00; and

WHEREAS, Borough Council wishes to amend the Schedule of Fees to increase the permit fee provided by Ordinance No. 1515 to \$20.00 per day and \$300.00 per season (not to exceed six (6) months), respectively, thereby repealing and replacing Ordinance 1515 in its entirety;

NOW, THEREFORE, IT IS ORDAINED and ENACTED by the Council of the Borough of McKees Rocks, as follows:

SECTION 1: Section 5d of Ordinance 1406 shall be amended to read as follows:

No such license shall be issued unless a license fee of Twenty Dollars (\$20.00) is first paid to the Borough Secretary.

SECTION 2: Be it further ordained that in lieu of the daily license fee, a seasonal permit may be obtained at a cost of \$300.00 per season. A season is determined to be a period of time not to exceed six (6) months.

SECTION 3: Ordinance 1515 is hereby repealed and replaced.

SECTION 4: The licensing fees contained herein may be modified by time to time in the enactment of a later resolution by the Council of McKees Rocks Borough.
