BOROUGH OF McKEES ROCKS

AN ORDINANCE OF THE BOROUGH OF McKEES ROCKS, ALLEGHENY COUNTY, PENNSYLVANIA, REPEALING AND REPLACING ORDINANCE NO. 1647

WHEREAS, The Borough of Council of the Borough of McKees Rocks deems it necessary to control the use of sidewalks within the Borough of McKees Rocks that safe passage is available to persons using said sidewalks, and for the overall safety of the Public.

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of McKees Rocks in regular meeting assembled, as it is hereby ordained and enacted by with the authority of the same as follows:

<u>Section I:</u> Person shall mean and includes any natural person, partnership, association, firm corporation or business.

- (a) Sidewalk vending is prohibited. It shall be unlawful for any person or business to occupy or to use any sidewalk or any portion thereof, or to place signs, signboards or other devices upon the sidewalk.
- (b) Except as authorized in Section (f) of this Section, it shall be unlawful to park or store upon any sidewalk any item, including, but not limited to, the following: any boxes, barrels, grills, furniture, tables, racks, crates, lumber, bricks, vehicles, bicycles, motorcycles, motorized scooters or auto parts.
- (c) It shall be unlawful for any owner or contractor to obstruct any sidewalk in front of any building in the process of erection or being repaired without a permit; but such sidewalks shall always be kept open for public traffic and such sidewalks kept in a safe and passable condition.

- (d) It shall be unlawful to permit any garbage, rubbish, debris, snow, ice or any other matter to remain upon or interfere with the free use of any sidewalks.
- (e) Sandwich board signs shall not be permitted on any Public Right of Way. This prohibition shall be interpreted to prohibit the display or placement of sandwich board signs on a permanent or temporary basis.
- (f) Permanent planters and garbage receptacles for Borough beautification purposes may be installed on Borough sidewalks. Placement of such beautification items shall ensure that sidewalks are kept in a safe and passable condition as per the guidelines of the American Disabilities Act.

<u>Penalties</u>: Any person who shall violate any provision of this ordinance shall upon conviction thereof be sentenced to pay a fine of not less than one hundred (\$100.00) and not in excess of six hundred (\$600.00) and cost of prosecution, and in default of payment of such fine and costs to undergo imprisonment for not more than thirty (30) days.

This Ordinance hereby repeals and replaces Ordinance 1647.
