A motion was made by Councilman Malesnick and second by Councilwomen Arlott to approve pay app (final) to Bosetti Lawn Care in the amount of \$12,495.00 for slope restoration

along Thompson Ave, which is reimbursable through grant funds. Motion was adopted by acclamation.

NEW BUSINESS: West Carson St Bridge Rehab Project – Borough Responsibility 5 % (Informational): Borough Engineer preliminarily discussed the project with Council, advising of the 5 % cost borough responsibility. The Council is seeking additional information of the project i.e project cost/plans/scope of work, before making any motion to accept the cost responsibility.

Next, a community basketball tournament is being held at Pleasant Ridge on March 29th. On the morning of April 5th at 10 am Athletes of action is sponsoring a scholarship luncheon. Also, on April 5th from 2-6 the 5th annual April fool's day parade is being held in the McDonalds parking lot. This is being sponsored by Level Equity housing who is also opening a brick motor in the old PNC bank. The mayor urged everyone to stop if they are interested in purchasing a home here in the borough. Lastly, tickets for the Easter K9 event on April 13th from 9am to 1pm are on sale.

• <u>Borough Manager</u>: - A motion was made by Vice-President Mixter and second by Councilwoman Arlott to approve temporary traffic flow restrictions on 4/05/25 for April Fool's Parade from Island Ave to McDonalds Way for approximately 20-30 minutes (starting 2pm), hosted by the MRWomen's Alliance. GENERAL FUND: Income and Expenses have an annual budget of \$5,132,848. As of February 28, Income was \$575,276.94 or 11.2% of the budgeted Income. Expenses were \$667,475.65 or 13% of the budgeted Expenses. Balance in the General Fund as of February 28, was \$1,135,766.69 (includes a \$300K CD).

SEWER FUND: Income and Expenses have an annual budget of \$2,422,000. As of February 28, Income was \$196,752.56 or 8.1% of the budgeted Income. Expenses were \$40,264.30 or 1.7% of the budgeted Expenses. Balance in the Sewer Fund as of February 28, was \$1,315,754.51 (includes a \$400K CD)

CSX ACCOUNT: \$626,614.41

LIQUID FUELS: \$22,001.97
