- Borough Solicitor:
- 1. A motion was made by Councilwoman Holland and second by Councilwoman Arlott to approve Borough Ordinance 1787, naming West Carson Street Extension. Motion was adopted by acclamation.
- 2. A motion was made by Councilwoman Arlott and second by Councilman Malesnick to approve Borough Resolution 1713, increasing the occupancy/sale inspection fee of industrial properties from \$200 to \$300. Motion adopted by acclamation.
- 3. Updates to Furnace Street Ext Ownership Issues corrected with an Ordinance already on file, just needed recorded with the county
- 4. 228 Hickory Street Sale Process Council and Legal discussed options of how to dispose of the property and requirements of process. Sealed bid vs. live auction was discussed, each idea requiring proper public notice/legal advertisement. A motion was made by Councilwoman Arlott and second by Councilman Corrie to legally advertise for a live auction process of 228 Hickory sale. Councilman Malesnick opposed. Motion carries 8 Y 1 N.
- <u>Borough Manager:</u> No action items; Informational: Auditor will be on site July 15<sup>th</sup> to complete 2024 financial audit, 3<sup>rd</sup> quarter garbage bills will be mailed by end of June, Borough Insurance renewals are in process for August 1 renewal date, and reminder of change of council meeting schedule beginning July.

## **Controllers Report**:

GENERAL FUND: Income & Expenses have an annual budget of \$5,132,848.

As of May 31, Income was \$2,743,983.70 or 53.5% of the budgeted Income. Expenses were \$1,818,388.84 or 35.4% of the budgeted Expenses. Balance in the General Gund as of May 31, was \$1,966,839.18.

SEWER FUND: Income & Expenses have an annual budget of \$2,422,000. As of May 31, Income was \$751,235.63 or 31% of the budgeted Income. Expenses were \$524,241.46 or 21.7% of the budgeted Expenses. Balance in the Sewer Fund as of May 31, was \$1,386,260.42.
