• <u>Borough Engineer</u> – The monthly capsule report was presented by Borough Engineer on 10/03/2023 during caucus meeting.

- b.) A motion was made by Councilman Myers and second by Councilman McQuillan to approve pay app 1 (final) to Independent Enterprises in the amount of \$146,829.7 for 2023 road program project. Motion was adopted by acclamation.
- c.) A motion was made by Councilman Corrie and second by Councilwoman Arlott to approve pay app 1 to CTM Construction in the amount of \$193,342.64 for West Carson Street Ph 3, which is reimbursable by grant funds. Motion was adopted by acclamation.
- d.) A motion was made by Vice-President Mixter and second by Councilwoman Arlott to approve payment to State Pipe Services, Inc for sewer cleaning and televising Olivia Street in the amount of \$1,380.00, payable from sewer account. Motion was adopted by acclamation.

- <u>Mayors Report</u>: Mayor Flick thanked residents for participation. • Borough Manager:

- A motion was made by Councilman Myers and second by Councilwoman Arlott to approve GEDTF Grant Resolution for municipal parking lot, amount \$282,550.00. Motion was adopted by acclamation.

Controllers Report:

GENERAL FUND: Income and Expenses have an annual budget of \$4,612,200.00 As of September 30, Income was \$4,395,772.48 or 95.3% of the budgeted Income. Expenses were \$3,637,270.70 or 78.9% of the budgeted Expenses. Balance in the General Fund as of September 30, was \$1,500,696.58.

SEWER FUND: Income and Expenses have an annual budget of \$2,146,000.00 As of September 30, Income was \$1,638,398.03 or 76.4 % of the budgeted Income. Expenses were \$1,490,975.2 or 69.5% of the budgeted Expenses. Balance in the Sewer Fund as of September 30, was \$1,059,026.91.

CSX ACCOUNT: \$555,505.90

ARPA RECOVERY: \$105,421.00

LIQUID FUELS: \$170,843.27

- (New Business) A motion was made by Councilman Gallagher and second by Councilman Malesnick to authorize Borough Manager to legally advertise the 2024 preliminary budget for preliminary Council adoption at the November 2023 voting meeting. Motion was adopted by acclamation.
