Balance in the General Fund as of November 30, was \$1,467,495.07.

SEWER FUND: Income and Expenses have an annual budget of \$2,299,500.

As of November 30, Income was \$1,957,197.31 or 85.1% of the budgeted Income.

Expenses were \$1,759,081.20 or 76.5% of the budgeted Expenses.

Balance in the Sewer Fund as of November 30, was \$1,300,458.28.
