• <u>Borough Engineer</u> – The monthly capsule report was discussed during the December 06, 2022 Council workshop meeting.

- a.) A motion was made by Vice-President Mixter and second by Councilman McQuillan to approve Pay Application No 1 in the amount of \$53,390.712 to Pride Masonry for the 2022 Catch Basin Project. Motion was adopted by acclamation.
- b.) A motion was made by Councilman Myers and second by Councilman McQuillan to award Gemm Demolition LLC as lowest responsible and responsive bidder for Ph 1 Demolition Project 433,435, and 437 Alexander Street, in the amount of \$38,000.00. Motion was adopted by acclamation.
- c.) A motion was made by Councilman Myers and second by Councilman McQuillan to approve Pay Application No. 5 in amount of \$32,059.60 to CTM Construction for West Carson Street Ph 1 Project, which is reimbursable through the grant. Motion was adopted by acclamation.
- <u>McKees Rocks Police Department</u> Police Chief Richard Deliman read the monthly November 2022 activity report. A copy is on file at the Borough Manager office.
- <u>McKees Rocks Code Enforcement Officer</u> –A written monthly November 2022 Code Enforcement Activity Report was provided to Council for review and read aloud by Borough Manager Wozniak. A copy is on file at the Borough Manager office.

- <u>Volunteer Fire Department</u> McKees Rocks VFD provided a written monthly activity report for the month of November 2022, no one was present to read. No report was provided by Presston VFD.
- <u>Mayors Report</u>: Mayor David Flick offered positive comments to the community regarding numerous community events: Shae & Bae's Turkey Drive, McKees Rocks Police Department Santa Paws Fundraiser, Alternative Response Program gathering at the F.O.R Center, Bosetti Landscaping for assisting Borough and residents on various projects. Mayor Flick also expressed his gratitude for holding the position of Mayor for 1 year, and is excited for what the upcoming year will bring.

- a.) A motion was made by Vice-President Mixter and second by Councilman McQuillan to advertisement Borough Ordinance no 1775, replacing 1647 Use of Borough Sidewalks for 2023 adoption. Motion was adopted by acclamation.
- b.) A motion was made by Councilman Corrie and second by Councilman McQuillan to approve Borough Resolution 1687, Act 57 of 2022 Waiver of Additional Charges for late payment of real estate taxes. Motion was adopted by acclamation.

• Borough Manager:

Both Brinza and Mixter voted No, stating they feel the extension should have been only for 6 months, and revisited. Motion carries.

 c.) A motion was made by Vice-President Mixter and second by Councilman Corrie to approve Denton Cohen & Grigsby Lobbyist Biennial Renewal with \$300 registration fee. Motion was adopted by acclamation.

Controllers Report:

<u>GENERAL FUND</u>: Both Income and Expenses have an annual budget of \$4,741,650.00. As of November 30, 2022 the Income was \$4,958,688.36 or 104.6% of the budgeted Income. Expenses were \$4,517,960.52 or 95.3 % of the budgeted Expenses. Balance in the General fund accounts as of November 30, 2022 was \$ 979,884.49.

<u>SEWER FUND</u>: Both Income and Expenses have an annual budget of \$2,209,000.00. As of November 30, 2022, the Income was \$1,993,535.68 or 90.3% of the budgeted Income. Expenses were \$1,759,424.87

or 79.7 % of the budgeted Expenses. Balance in the Sewer Fund accounts as of November 30, 2022 was \$666,885.66.

LIQUID FUELS FUND: As of November 30, 2022 balance in the Liquid Fuels Account \$ 1,651.35

<u>COVID-19 ARPA Recovery Fund:</u> As of November 30, 2022 balance in the COVID-19 ARPA Recovery Fund is \$111,107.05.

CSX Account: As of November 30, 2022 balance in the CSX Account was \$743,493.85.
