2020 Reorganization Meeting Minutes  
January 6, 2020

**Pledge of Allegiance**

**Roll Call**

The meeting was called to order by Council (President) Paul Krisby. Roll call requested with Council Joe Mixter, Council Sarah Harvey, Council Craig Myers, Council (Vice-President) Kathy Evich, Council (President) Paul Krisby, Council Leslie Walker, and Mayor Jack Muhr. Borough Manager Ruth A. Pompey, Administrative Assistant LeeAnn Wozniak, and Solicitor Lisa Coulatti, of Weiss Burkhardt Kramer, LLC were present as well.

**Oaths of Office**

District Justice Bruce A. Boni, administered the Oath(s) of Office to all newly elected and re-elected Borough officials, as follows:

**Reorganization of Council**

A motion was made by Council Maritz and seconded by Council Walker to elect Solicitor Lisa Coulatti as the temporary Reorganization Chairperson. Solicitor Coulatti opened the floor for nominations of Council President. Motions were made as follows: Council Mixter to nominate Council Krisby (accepted), Council Delgado to nominate Council Harvey (accepted), and Council Harvey to nominate Council Maritz (declined). A motion was made by Council Maritz and seconded by Council Harvey to close nominations for Council President. Roll call requested, resulting in 7 voting (Mixter, Myers, Evich, Krisby, Walker, Maritz, Brinza) in favor of Council Krisby and 2 voting (Harvey, Delgado) in favor of Council Harvey as Council President. Motion carries for Council Krisby as Council President.

President Krisby now presided over the meeting and asked for nominations for Council Vice-President. Motions were made as follows: Council Mixter nominated Council Evich (accepted) and Council Delgado nominated Council Harvey (accepted). A motion was made by Council Delgado and seconded by President Krisby to close nominations for Council Vice-President. Roll call requested, resulting in 7 (Mixter, Myers, Evich, Krisby, Walker, Maritz, Brinza) voting in favor of Council Evich and 2 (Harvey, Delgado) voting in favor of Council Harvey as Council Vice-President. Motion carries for Council Evich as Council Vice-President.

**Administrative Appointments and Reappointments**

A motion was made by Council Myers and seconded by Council Walker to appoint/reappoint the listed individuals to the listed positions as follows:

- i. Ruth A. Pompey as Borough Manager/Secretary/Treasurer/Pension Administrator/Right to Know Officer
- ii. LeeAnn Wozniak as Assistant Borough Secretary and Assistant Right to Know Officer

- iv. Mr. Thomas McAllister as Code Enforcement Officer
- v. Mr. Donald V. Baird III as Emergency Operations Management Coordinator.

Council Delgado asked Solicitor Coulatti if grouping individual appointment/reappointment(s) as one motion is permitted, as Council has not voted this way in past. Solicitor Coulatti responded advising there is nothing prohibiting Council voting this way, unless majority requests to vote individually. Council Delgado opposed the motion to approve individuals' appointment/reappointment as a group vote. Roll call requested, resulting in 8 Yes and 1 No (Delgado) to appoint/reappoint individuals as listed with position(s). Motion carries.
