Borough of McKees Rocks Capsule Engineer's Report January, 2019

- 1. Construction has proceeded on Sefler Street stairs. Contractor (A. Merante Contracting, Inc.) has completed stairs, wall blocks, and grading. The railings, runnels, and repair of sidewalk and Bouquet Street remains. We have approved A. Merante Contracting, Inc. invoice of \$98,703.00 which is Progress Payment No. 1.
- 2. Paul, Ruth and I have met with Alcosan representatives regarding funding for Catherine street storm inlet removal project. The PA Small Water Grant will cover both the replacement of sewer within Gardner Street and the relocation of stormwater from five (5) inlets. Alcosan will only fund the latter. Therefore, we are studying the feasibility of replacing the 12" diameter sanitary sewer within Gardner Street based on limited space and the presence of water and gas lines. Alcosan will require Geotechnical Report of soils at proposed infiltration site to be completed before this June. Engineer requests authorization to have Geotechnical Engineer complete infiltration study.
- 3. As learned through Speedway Engineer, Speedway is seriously evaluating the reconstruction of lower Churchill Street. We have placed existing utility companies which occupy lower Chuchill Street on notice, to provide them the opportunity to replace existing utility lines.
- 4. All comments regarding Zoning, SALDO, and stormwater have been addressed by the Developer's Engineer for the "Rocks Intermodal Way Building #1." Our letter has requested.
 - a. NPDES/E & S Approvals
 - b. Developers Agreement
 - c. Building Permit Application
 - d. Stormwater Maintenance Agreement
 - e. Easement Agreement for Bike Trail
- 5. We received Payment Request No. 1 for \$14,602.50 from U&S Construction for the Chartiers Avenue Curb Ramp Upgrades, for which we recommend Board Approval for Char-West COG to process for payment. We also submitted a letter to U&S Construction, to see if they needed to extend the Contract for the remaining portion of this work.
- 6. We submitted a Tap Allocation Request (January 1, 2019 July 1, 2019) to PA DEP. Response from DEP was received which approves the Corrective Action Plan (CAP) through June 30, 2019.
- 7. We have approved Insight Pipe Contracting, LLC Invoice of \$17,607.00 for internal sewer lining of 15" diameter concrete pipe within Gertrude Alley.
- 8. The design of the Phase 2 Stair Replacement project (Fourth Street Stairs) has proceeded through Preliminary Engineering. The project will not be advertised for bidding until Phase 1 grant is processed.
- 9. We received payment Request No. 3 (Final) for \$2,380.50 from Insight Pipe Contracting, LLC for the 2018 Sewer Cleaning and Televising project and recommend

payment. We have reviewed the video reports provided by Insight and are compiling a list of pipe defects. We are also preparing letters to certain homeowners to notify them that roots were noted within their lateral.

BUILDING CODE OFFICIAL BOROUGH OF MCKEES ROCKS

ORDINANCE NO. 1706

AN ORDINANCE OF THE BOROUGH OF McKEES ROCKS, ALLEGHENY COUNTY, PENNSYLVANIA, INCREASING THE LICENSE FEE FOR VIDEO, ELECTRONIC OR MECHANICAL AMUSEMENT DEVICES AND PINBALL MACHINES TO SIX HUNDRED FIFTY (\$650.00) DOLLARS.

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of McKees Rocks in regular meeting assembled, a it is hereby ordained and enacted by and with the authority of the same as follows:

SECTION 1: Section 6 of Ordinance 1409 as amended by Ordinances 1481, 1527, 1535 and 1579 is amended to read as follows:

SECTION 6: Following the waiting period of Section 4 of Ordinances 1409 and 1481, owners of video, electronic or mechanical amusement devices and music boxes will pay a yearly license fee for each machine as follows:

A. \$650.00 for video, electronic or mechanical amusement devices and pinball machines.

B. \$175.00 for pool tables, dart boards, bowling machines, music boxes and the like.

Upon receipt of payment for each machine, the Borough Secretary shall issue a license to each applicant. Such license shall be valid for the entire calendar year for which it is issued and shall expire following the last day of such calendar year. However, should any such device or box be installed after July first of any year and application therefore be made after such date, then in such event the license for the particular year shall be one half (1/2) of the regular license fee.

SECTION 2: Any Ordinance or parts of Ordinances conflicting

with the provisions of this ordinance are hereby repealed to the extent of such conflict.
